Usage Policy:

- Please ensure that when utilizing booked pool time, you arrive in good time before the session is due to start. You will also need to ensure that you and your party vacate the pool no later than the time specified by the time of booking.
- If you and your party wish to stay later than your booked rental time, you will be charged accordingly (general admission fees).
- An individual who books sessions at the Shellbrook Swimming Pool is responsible for the group using the pool for that booking. It is therefore expected of this individual to ensure that their particular group leaves the facility in the way that it was found. Should damage be found, the deposit fee will not be returned.

Cancellation Policy:

- A 50% deposit fee must be paid in CASH at the time of booking.
- The remaining rental fees must be paid by no later than the day of the rental, and the 50% deposit fee will be returned at the completion of the private rental session.
- If preventable damage occurs during the rental OR if the rental is cancelled due to any circumstances, the 50% deposit fee will NOT be returned. The deposit fee covers the costs of reservations, damage, staffing, and cancellations.
- All cancellations are to be made to the Head Guard.

Other Important Information:

- Lifeguards are to enforce all policies/rules at all times for swimmer safety; any misbehavior may lead to the lifeguard(s) asking the participant(s) to leave the premises. In this case the renter will NOT be granted a refund.
