A Bylaw to amend Bylaw No. 2012-06 known as the Official Community Plan.


The Council of the Town of Shellbrook, in the Province of Saskatchewan, enacts this bylaw to amend Bylaw No. 2012-06 as follows:

1. The Future Land Use Concept Map, located in Section 5 – Maps, is amended by redesignating from partially Community Service and partially Open Space to Commercial, the following Parcels:
  - Parcel 53, Plan 101718075 Ext. 11 (Surface Parcel No. 147620000);
  - Parcel 52, Plan 101718086 Ext. 10 (Surface Parcel No. 147619996); and
  - Parcel 51, Plan 101718097 Ext. 10 (Surface Parcel No. 153449220).

As shown on the attached Schedule “A” which forms part of this bylaw.

2. This bylaw shall come into force and take effect when approved by the Minister of Government Relations.

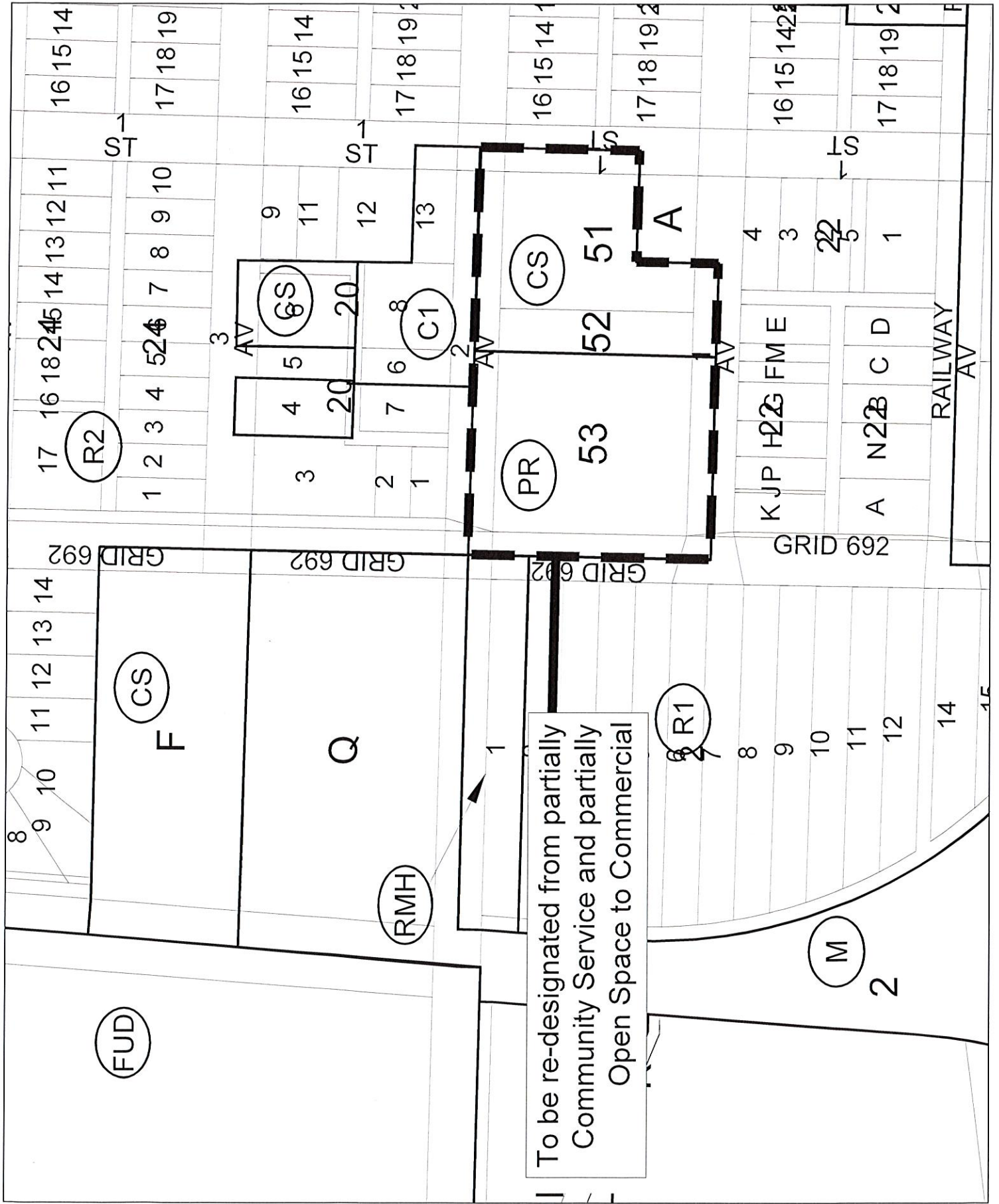
