### Bylaw No. 03 - 2010

A Bylaw of the Town of Shellbrook to control and regulate the construction, erection, maintenance, repair and demolition of private swimming pools.

enacts as follows: The Mayor and Council of the Town of Shellbrook, in the Province of Saskatchewan,

- . This Bylaw may be cited as "The Private Swimming Pools Bylaw"
- 2 The purpose of this bylaw is:
- (a) To control and regulate the construction, erection, maintenance, repair and
- **(b)** demolition of private swimming pools; and To specify, regulate and enforce the use of safety measures in connection with private swimming pools.
- S. In this bylaw:
- (a) "Town" means The Town of Shellbrook;

- <u>O</u> "occupant" includes a person residing at a property upon which a private swimming pool is situated or a person entitled to the property's possession if there is no person residing there and a leaseholder;



- (a) section. Every private swimming pool must be enclosed in accordance with this
- **(b)** The enclosure must be built prior to the swimming pool being filled with
- (c) The enclosure must be properly maintained to comply with this Bylaw at all times.

- (i) The enclosure must have a minimum height of 1.5 meters measured on the exterior, or non-pool, side from the top of the enclosure to the nearest platform, deck or grade;
- $\Xi$ opening to the other; and 20 millimeters measured horizontally from one side of the gap or The enclosure must not contain any gaps or openings which exceed
- (iii) Notwithstanding subsection 6(d)(ii) of this Bylaw, if a fence forms part of an enclosure, the following will apply:
- (a) Parallel horizontal structural members, the tops of which are at least 1100 millimeters apart as illustrated in the following diagram, may be located on the outside or non-pool side of the fence;



- (b) Parallel horizontal structure members, the tops of which are less than 1100 millimeters apart, must be on the inside or pools side of the fence;
- (c) Gaps of up to 100 millimeters are permitted between vertical fence boards or other vertical structural members if parallel structural members are spaced at least 1100 millimeters apart.
- (d) Where diagonal structural members are used, they must be on the inside or pool side of the fence and gaps between the vertical members must not exceed 20 millimeters.
- (e) If the fence is chain link, the mesh size must not exceed 50 millimeters and the wire core must not be less than 11 gauge.

# Gates and Self-Closing Devices

- (a) A gate which forms part of an enclosure must comply with the following:
- (i) a gate must comply with the requirements for fences in Section 6(d).
- (ii) all gates must be installed to swing outward in the direction away from the swimming pool.
- (iii) all gates must be equipped with a self-closing device designed to return the gate to the closed position after each use, a self-latching device designed to hold the gate in the closed position after each use, and a locking device;

- (iv) must be maintained in working order at all times; and the self-closing device, self-latching device and the locking device
- 3 both the hinge and latch sides. all gates must be anchored to fixed posts or secure structures on
- **(b)** constructed before the passage of this Bylaw. The requirement in Section 7(a)(ii) does not apply to swimming pools

### 000 Securing of Swimming Pool

When a swimming pool is not attended by the owner or occupant, gates, doors and other entrances to the swimming pool area must be locked.

#### 9. Hot Tubs

In the case of a private swimming pool which is a hot tub, the requirements of sections 5, 6, 7 and 8 of this Bylaw do not apply if all of the following provisions are complied with:

- (a) the hot tub does not exceed 2.4 meters across the widest portion of the water surface;
- 9 the hot tub has a cover with the strength to support the weight of an adult walking across the top;
- 0 unauthorized persons; and the hot tub has a lockable device to prevent access to the water by
- (d) unsupervised. the cover is maintained in place and locked at all times when the hot tub is

#### 10. Walkway

- (a) Within the enclosure, a swimming pool must have a properly maintained access walkway around the swimming pool with a minimum width of 750 the swimming pool. millimeters. The walkway must be within 1200 millimeters of the top of
- <u></u> The requirement found in Section 10(a) does not apply to swimming pools constructed before June 7, 1971.

#### 11. Safety Devices

- **(3)** No person shall drain the water of a swimming pool into any adjacent public or private property or any street, lane or walkway.

## 13. Offences and Penalties

- (a) Every person who contravenes a provision of this Bylaw is guilty of an offence and liable on summary conviction to a minimum fine of \$100.00 and a maximum fine of \$1,000.00.
- **(b)** A conviction for a contravention of any provision of this Bylaw does not relieve the person convicted from complying with this Bylaw, and the convicting judge or justice may, in addition to the fine imposed, order the person to do any act or work within a specified time, to comply with this
- <u>O</u> order imprisonment of an individual for a term not exceeding one year. The Court may, in default of payment of a fine imposed under this Bylaw,
- 14. This Bylaw comes into force on the day of its final passing.
